

## ELK VALLEY CRAFTERS SHOW

### RULES Please keep for your Records

- ALL Work must be original, finished and produced by the Craftsman. NO FLEA MARKET items or NO DIRECT SALES. If you have non-handmade items in your booth you will be asked to remove them and could be asked to Leave the show. You will forfeit your booth fee.
- Early application does not necessarily mean acceptance into the show. First come, first serve. There will be no reserving booths for the show. There is no guarantee of setting up in the same space each show but we will do our best to accommodate if possible.
- No set-up will be allowed for anyone until the appointed time. NO EXCEPTIONS. We are using the Lincoln County High School facilities and must work around school activities.
- Crafters must register with the Show Committee before setting up. The Show Committee will be located in the Commons Area. Packets will be available for you at this time.
- Each Crafter must furnish their own display equipment and accessories, Including electrical cords. Tables should be draped to the floor on all sides. Backdrops and displayed items shall not exceed the maximum of 8' high and must be finished front and back. Each crafter will stay within the allotted space including provisions for entrance and exit. This applies to overhanging exhibits as well.
- Unprofessional conduct and/or failure to comply with Show Rules are just cause for removal from the show.
- Trash pickup and space cleanup is the responsibility of the Crafter.
- No open flames or candles are allowed by order of Fayetteville Fire Marshall.
- When using stains, paints, etc. a protective covering MUST be placed on the floor, under and around work. NO paint or other materials may be sprayed during show.
- NO dismantling or packing of merchandise prior to show closing. Any exhibitor in violation will be banned from future shows for a period of two (2) years or four (4) shows.
- Lincoln Count TN sales tax rate is 9.5%. Collecting & reporting is the responsibility of exhibitor.

- Lincoln County High School and Elk Valley Crafters Association will NOT be held responsible for loss or damage of any kind.
- No photography allowed other than your own booth. An EVCA representative may take pictures, but will need your permission.
- Smoking is prohibited on School grounds.
- Booth space is limited to four per person/business.
- A signed copy of the Show Rules must accompany each Show Application.

## **PARKING**

- Vehicles are not allowed on the sidewalks at any time.
- Once unloaded, crafters should move their vehicle to the South Parking Lot or area away from the Loading area. **ALL CRAFTERS VEHICLES MUST BE PARKED IN SOUTH PARKING LOT DURING THE SHOW. CUSTOMERS WILL BE PARKING NEAR THE BUILDINGS.**

## **FEES**

- Only one Crafter permitted to sell/display per booth. If more than one (1) crafter displaying there will be a \$25 fee.
- Late fees are due after Entry Deadline.
  - Spring Show deadline is April 1st- Late fee is \$15.00
  - Christmas Show deadline is October 15th - Late fee is \$15.00
- \$10.00 handling fee on all Cancellations. There will be NO refunds on cancellations made within 30 days prior to show.
- \$30.00 returned check fee.
